Discussion was held concerning ideas for the fountain area.

Mr. Fagan questioned whether the fountain pump could be refurbished rather than replaced. He will contact Scott Baker, Public Works Director, for additional information.  
Ms. Condon was disappointed that the community garden was not moving forward.

Ms. D'Onofrio Halladay commented that a community garden group could be formed as a separate entity from CRAB.  
Ms. Condon will be responsible for the food.
