

RESOLUTION NUMBER 20-48

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF FORT MYERS BEACH, FLORIDA REGARDING APPLICATION VAR 20200052, FOR A VARIANCE TO THE REQUIREMENTS OF THE FORT MYERS BEACH LAND DEVELOPMENT CODE FOR THE PROPERTY LOCATED AT 4690/4700 ESTERO BOULEVARD; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Florida Statutes provide that municipalities shall have the governmental, corporate, and proprietary powers to enable them to conduct municipal government, perform municipal functions, and render municipal service, and exercise any power for municipal purposes, except when expressly prohibited by law; and

WHEREAS, Article X of the Town Charter of the Town of Fort Myers Beach empowers the Town to adopt, amend, or repeal such ordinances and resolutions as may be required for the proper governing of the Town; and

WHEREAS, applicant Claudia Metcalfe (“Applicant”), owner of the property located at 4690/4700 Estero Blvd. (“Property”), is requesting a variance from Sec. 34-1174(b) of the Town of Fort Myers Beach Land Development Code (“LDC”); and

WHEREAS, the STRAP number for the Property is 29-46-24-W3-008J0.0030 and the legal description of the Property is attached as *Exhibit A*; and

WHEREAS, the Property is located in the ‘Residential Conservation’ and ‘Environmentally Critical’ zoning district of the Official Zoning Map and the ‘Mixed Residential’ category of the Future Land Use Map of the Comprehensive Plan of the Town of Fort Myers Beach, Florida; and

WHEREAS, a public hearing on this matter was legally noticed and held before the Local Planning Agency (LPA) on October 13, 2020, at which the LPA gave full and complete consideration to the request of Applicant, recommendations of staff, the documents in the file, and the testimony of all interested persons, as required by Section 34-84 of the LDC; and

WHEREAS, on November 2, 2020 the Town Council held a duly noticed public hearing to fully consider the request of the Applicant, the recommendations of Town staff and the LPA, the documents in the record, and testimony of all interested persons as required by LDC 34-87, and the Town Council determined it is in the best interest of the Town to approve the request.

NOW THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF FORT MYERS BEACH, FLORIDA, AS FOLLOWS:

Determination:

Based upon the recommendations, testimony, and evidence presented by the applicant, Town staff, and interested parties, the Town Council **APPROVES WITH CONDITIONS** the following:

- A. A variance from Sec. 34-1174(b) of the LCD – “Locational Regulations in Conventional Zoning Districts” - to allow an accessory structure to be located closer to the street right of than the principal structure, specifically a variance of 60 feet from the required 126.6 feet front setback distance compared to the principal structure.

Findings and Conclusions:

In accordance with the requirements of Sections 34-84 and 34-87 of the LDC regarding consideration of eligibility for a variance, the Town Council makes the following findings and reaches the following conclusions:

- A. There are exceptional or extraordinary conditions or circumstances that are inherent to the property in question, and the request is for a de minimus variance under circumstances or conditions where rigid compliance is not essential to protect public policy.
- B. The conditions justifying the variance are not the result of actions of the applicant taken after the adoption of the regulation in question.
- C. The variance granted is not the minimum variance that will relieve the applicant of an unreasonable burden caused by the application of the regulation to the property in question.
- D. The granting of the variance will not be injurious to the neighborhood or otherwise detrimental to the public welfare.
- E. The conditions or circumstances on the Property for which the variance is sought are not of so general or recurrent a nature as to make it more reasonable and practical to amend the regulation in question.

Conditions of Approval:

1. *Nothing in the approval of this variance, including any of the attached conditions, may be construed as a variance or deviation from the provisions of LDC Chapter 6, Article IV Floodplain regulations. Approval of this variance does not exempt the Property from any provisions of the LDC with the exception of the approved variance.*
2. *Approval of this variance does not give the Applicant an undeniable right to permit approval. Development or redevelopment of the subject property must comply with all applicable requirements of the Fort Myers Beach Comprehensive Plan and Land Development Code in effect at the time of permit approval, except as specifically modified herein.*
3. *The variances shall only apply to the proposed accessory structure location as shown on the provided site plan dated 05/11/2020 by Kukk Architecture and Design. No deviations from the measurements of that site plan greater than 0.1 feet shall be permitted.*

3. *The variances shall only apply to the proposed accessory structure location as shown on the provided site plan dated 05/11/2020 by Kukk Architecture and Design. No deviations from the measurements of that site plan greater than 0.1 feet shall be permitted.*
4. *A type B landscape buffer, per LDC Sec.10-416, shall be installed and maintained adjacent to single-family uses and right-of-way to mitigate visual impacts.*
5. *Total height of the any structure is limited to the height of the existing principal structure.*

Effective Date.


This Resolution shall take effect immediately upon adoption.




