**I. CALL TO ORDER**

Meeting was called to order at 3:00 p.m. by Chair Johnson.

**VII. CURRENT ITEMS**

**A. Invasive Vegetation Inventory**

MRTF Member Larkin noted that she was scheduled to take the Master Gardner test on December 10, 2020, and she would be the project leader for Fort Myers Beach. She indicated they had to create a checklist of exotic plants. Manager Chustz mentioned Australian Pine, Carrotwood, Scaevola, Air Potato, Brazilian Pepper and Lead Trees.

He suggested adding the size of the tree. MRTF Member Larkin stated that their project would have a sign-up sheet for volunteers and she felt that many would participate. MRTF Member Fossum noted that the two pine trees in his neighborhood had Osprey nests in them. It was determined the trees were probably Norfolk Pines rather than Australian Pines.

**B. Fertilizer Education**

Manager Chustz indicated that he was waiting to hear back regarding whether condo maintenance workers were required to obtain an applicator license. He reported that they started handing out the information card to condo managers.

**C. FMB Dune Management**

Chair Johnson noted that Joanne Shamp's policy and the management plan were similar. He questioned whether they were interested in codifying the policy. MRTF Member Spalletta wondered how many zones were on the beach. Manager Chustz explained that managed beach zones were where dunes were created and maintained. Chair Johnson questioned whether they would include a Memorandum of Agreement (MOA) for property owners with managed beach zones. Manager Chustz replied affirmatively and noted a copy was in the file.

Chair Johnson questioned whether the property owner hired and paid for the contractor. Manager Chustz replied that the Town hired a contractor for a renourishment project and they mapped out the state of each property's dunes. He stated that property owners could use LEEPA (Lee County Property Appraiser website) to determine where the managed beach zone would be located. MRTF Member Spalletta questioned whether the Town paid for the plants. Chair Johnson replied that it was up to the homeowner now but they could suggest that the Town help offset costs in the future.

Discussion was held concerning raking. Chair Johnson noted that Turtle Time shared feedback with them and Manager Chustz commented that he would change the language to the Marine Permit Holder.

Manager Chustz stated that he would draft an ordinance and bring it back to MRTF.

**MOTION:** Chair Johnson moved to codify the Fort Myers Beach Dune Management Plan and extend it to the entire Island; second by MRTF Member Spalletta.

MRTF Member Fossum suggested that they simplify the plan so people could understand it. Manager Chustz agreed that it could be a one or two-page document. Chair Johnson explained that the ordinance would allow the dunes to be maintained to control the growth.

**VOTE:** Motion passed unanimously.

**D. Good Citizen Award aka the "Murphie"**

Manager Chustz stated that volunteers from Arthrex helped him clean up the beach in the EC zone last Friday.

**MOTION:** Chair Johnson nominated the volunteers of Arthrex; second by MRTF Member MRTF 20201209

Spalletta.  
**VOTE:** Motion passed unanimously.

Discussion was held regarding the schedule for articles in 2021. MRTF Member Larkin will write a piece for January.
