

**RESOLUTION NUMBER 22-28**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF FORT MYERS BEACH, FLORIDA, RATIFYING ACTION OF THE TOWN COUNCIL TAKEN IN REGULAR SESSION ON AUGUST 15, 2022 REGARDING THE NAMING OF ANN & DAN HUGHES LOOP; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, Florida Statutes provide that municipalities shall have the governmental, corporate, and proprietary powers to enable them to conduct municipal government, perform municipal functions, and render municipal service, and exercise any power for municipal purposes, except when expressly prohibited by law; and

**WHEREAS**, Article X of the Town Charter of the Town of Fort Myers Beach ("Town") empowers the Town to adopt, amend, or repeal such ordinances and resolutions as may be required for the proper governing of the Town; and

**WHEREAS**, throughout the history of the Town of Fort Myers Beach, Dan Hughes and his wife Ann have always had a special affinity and love for the grounds at Mound House and have contributed their time, talents and work along with generous donations and,

**WHEREAS**, the Town wishes to recognize Dan and Ann Hughes' contributions to Fort Myers Beach by naming the loop road around the Mound House grounds in their honor.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN OF FORT MYERS BEACH, AS FOLLOWS:**

Section 1. The above recitals are true and correct and are hereby incorporated by reference as though fully set forth herein and are hereby adopted as the legislative and administrative findings of the Town Council.

Section 2. This Resolution memorializes and ratifies the actions of the Town Council, as discussed at the August 15, 2022 regular Town Council meeting, naming the loop around the Mound House grounds as "Ann & Dan Hughes Loop" and directing Town staff to procure and install sign(s) to the name the loop road.


Section 3. This resolution shall take effect immediately upon its adoption by the Town Council of the Town of Fort Myers Beach.




