

RESOLUTION NUMBER 24-10

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF FORT MYERS BEACH, FLORIDA, ADOPTING THE NAME CHANGE OF BAYSIDE PARK TO BAYSIDE VETERANS PARK; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Florida Statutes provide that municipalities shall have the governmental, corporate, and proprietary powers to enable them to conduct municipal government, perform municipal functions, and render municipal service, and exercise any power for municipal purposes, except when expressly prohibited by law; and

WHEREAS, Article X of the Town Charter empowers the Town Council to adopt, amend, or repeal such ordinances and resolutions as may be required for the proper governing of the Town; and

WHEREAS, the public park known as Bayside Park is within the Town's jurisdiction and maintained by the Town; and

WHEREAS, the Town of Fort Myers Beach conducted an online public survey in December 2023 to rename the Town's downtown park known as Bayside Park; and

WHEREAS, the top choice received on the survey was Bayside Veterans Park; and

WHEREAS, the Town Council reached consensus at the December 18th, 2023, Town Council meeting to formally rename the park to Bayside Veterans Park in agreement with the survey's top choice.

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE TOWN OF FORT MYERS BEACH AS FOLLOWS:

Section 1. The above recitals are true and correct and are hereby incorporated by reference as though fully set forth herein and are hereby adopted as the legislative and administrative findings of the Town Council.

Section 2. This resolution formally changes the name of the park from Bayside Park to Bayside Veterans Park

Section 3. This Resolution shall take effect immediately upon its adoption.

The foregoing Resolution was adopted by the Town Council upon a motion by Council Member Council Member King and seconded by Council Member King, and upon being put to a vote, the result was as follows:
