

RESOLUTION NUMBER 25-321

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF FORT MYERS BEACH, FLORIDA, APPROVING 5 INDIVIDUAL PROFESSIONAL SERVICE AGREEMENT WITH THE FOLLOWING FIRMS, WHICH WERE NEGOTIATED BY TOWN STAFF AS DIRECTED BY THE TOWN COUNCIL ON AUGUST 18, 2025 IN RESPONSE TO RFQ-24-06-AD ENTITLED “ONGOING MISCELLANEOUS PROFESSIONAL SERVICES”: 1) BLOT ENGINEERING, INC. 2) FOREFRONT ARCHITECTURE AND ENGINEERING, LLC 3) PROFESSIONAL SERVICES INDUSTRIES, INC. 4) RG ARCHITECTS, P.A, 5) RWA ENGINEERING; AUTHORIZING THE TOWN MANAGER TO EXECUTE AN AGREEMENT WITH EACH OF THE TOP RANKED FIRMS FOR EACH CATEGORY OF WORK WITHIN THE REQUEST FOR QUALIFICATIONS AND WHICH WERE SUCCESSFULLY NEGOTIATED; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Florida Statutes provide that municipalities shall have the governmental, corporate, and proprietary powers to enable them to conduct municipal government, perform municipal functions, and render municipal service, and exercise any power for municipal purposes, except when expressly prohibited by law; and

WHEREAS, Article X of the Town Charter of the Town of Fort Myers Beach (“Town”) empowers the Town to adopt, amend, or repeal such ordinances and resolutions as may be required for the proper governing of the Town; and

WHEREAS, pursuant of the Town’s Purchasing Ordinance 24-11, Sec 2-480 (a) (1) (12) (14), the Town completed the competitive procurement process in compliance with state law and Town Code through the solicitation RFQ-24-06-AD “Ongoing Miscellaneous Professional Services” in July of 2024; and

WHEREAS, on August 18, 2025, the Town Council unanimously approved Resolution 25-244, which accepted the rankings of the professional services firms and recommendations of the Town Manager and the Selection Advisory Committee and authorized the Town Manager or designee to enter into negotiations with the top ranked firms; and

WHEREAS, negotiations with each of the top ranked firms (“Firms”) has been completed and draft agreements are prepared for award and approval by the Town Council; and

WHEREAS, awarding and authorizing execution of these professional service agreements allows the Town to utilize qualified professional firms for miscellaneous professional services that the Town may need throughout the agreement period within the categories of work included within the Request for Qualifications; and

WHEREAS, the Town Council finds and determines that it is in the best interest of the Town and its citizens to authorize the execution of professional services agreements with each of the top ranked firms.

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE TOWN OF FORT MYERS BEACH AS FOLLOWS:

Section 1. The above recitals are true and correct and are hereby incorporated by reference as though fully set forth herein and are hereby adopted as the legislative and administrative findings of the Town Council.

Section 2. That the Town Council hereby authorizes and instructs the Town Manager to execute the negotiated professional services agreements with each of the top ranked firms as determined in the previous Resolution 25-244 and a list of which is attached hereto as “Exhibit A”.

Section 3. This resolution shall take effect immediately upon its adoption by the Town Council of the Town of Fort Myers Beach.

The foregoing Resolution was by the Town Council upon a motion by Council Member Atterholt and seconded by Council Member Link, and upon being put to a roll call vote, the result was as follows:
