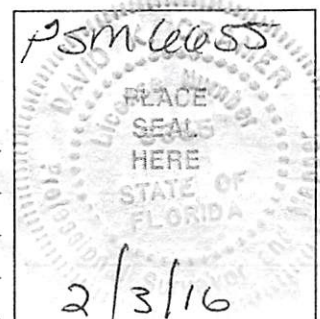

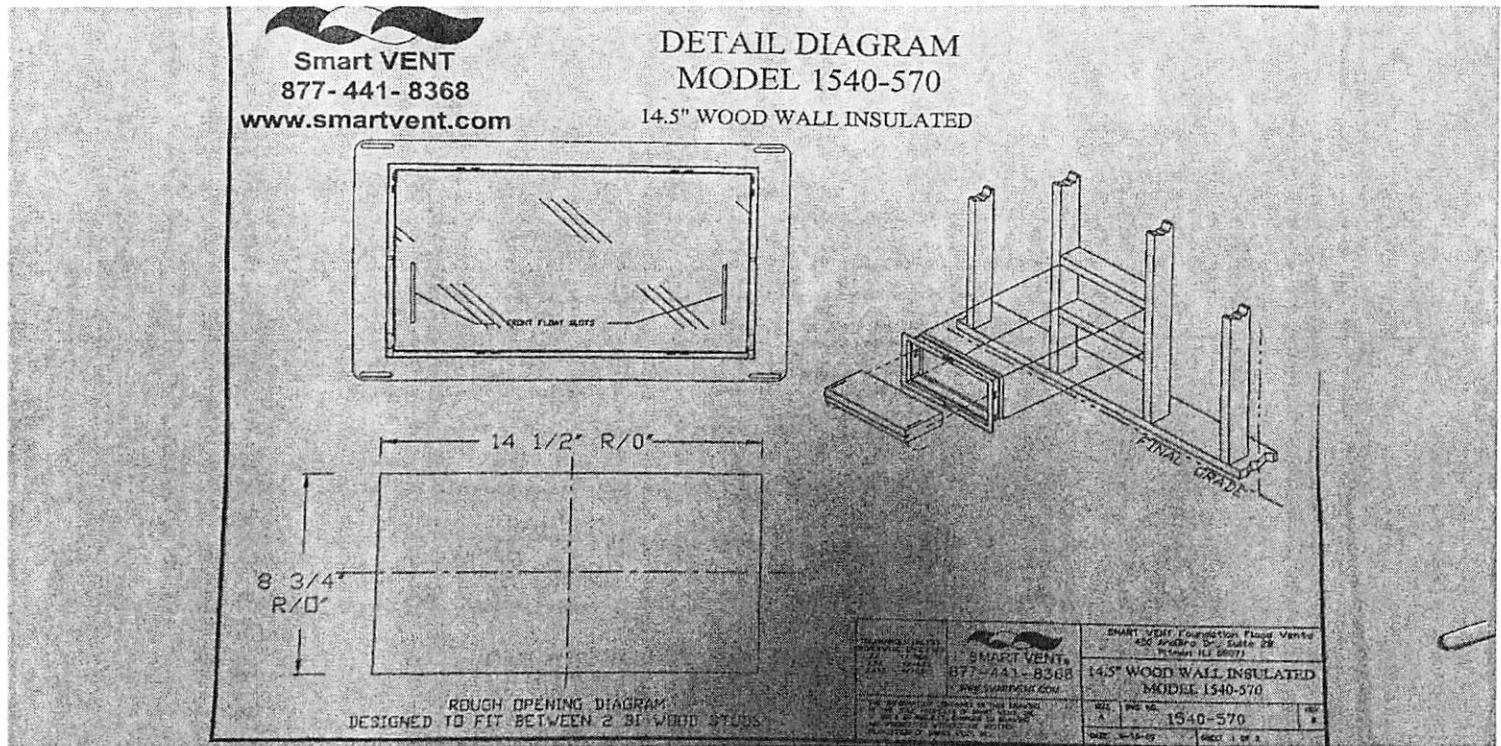


Side view with vent (02-11-16)

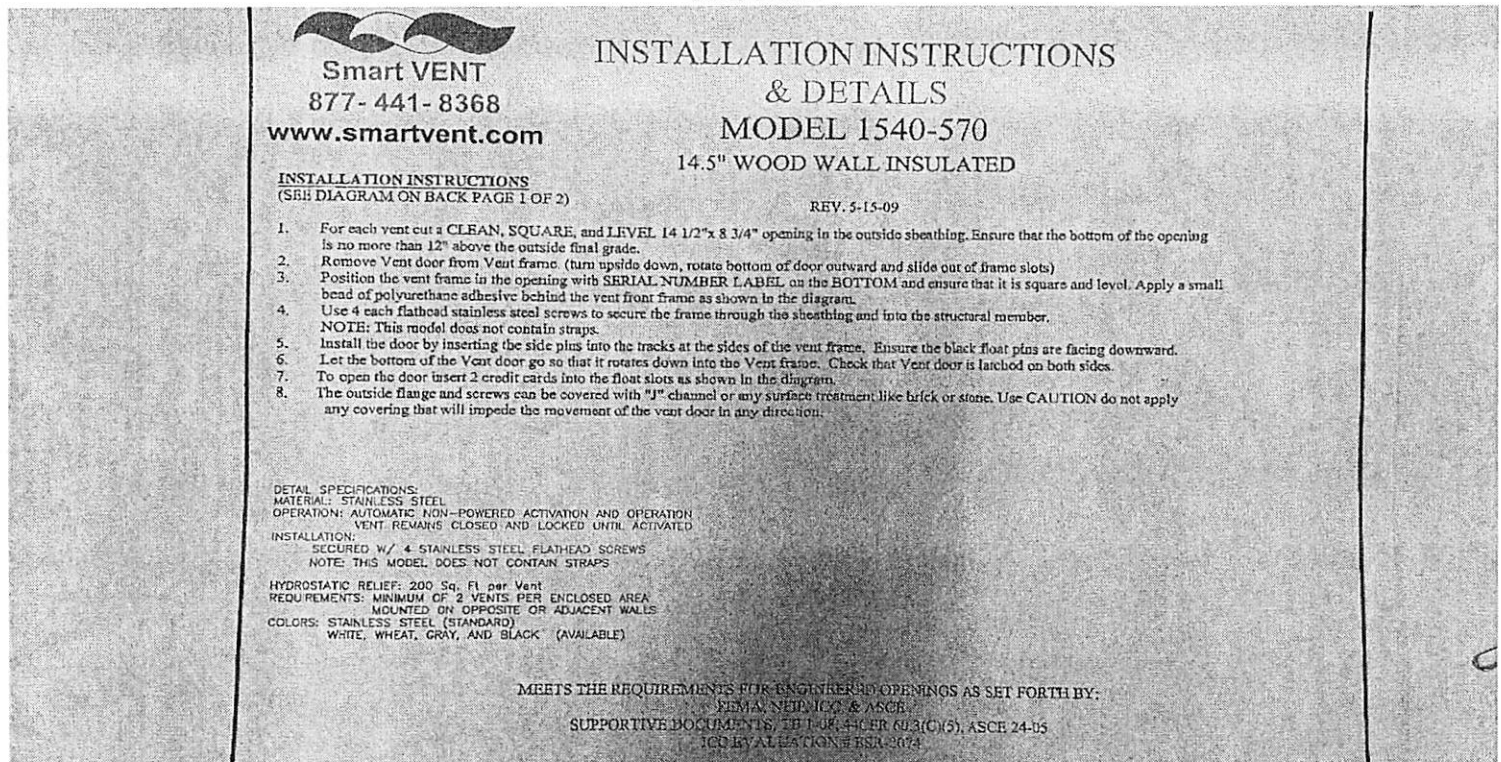
